Dear Sir,

This is pursuant to the pre-clearance letters dated September 14, 2021 provided to us for the sale of up to 80,000,000 Units held by us in the Embassy Office Parks REIT.

As required under the pre-clearance letter, and the Code on Unpublished Price Sensitive Information and Dealing in Units of the Embassy Office Parks REIT (the “**Code**”), we wish to inform you that:

- (i) The entities named below (forming part of the Blackstone Sponsor Group) have sold and transferred 56,999,997 Units (aggregating 6.01% of the total outstanding Units of the Embassy Office Parks REIT) (“**Transferred Units**”), currently traded on the BSE Limited and the National Stock Exchange of India Limited, pursuant to a bulk trade undertaken on the stock exchange platforms (the “**Trade**”) on September 15, 2021.
- (ii) In anticipation of the Trade, we had (pursuant to the pre-clearance letter dated September 14, 2021) secured the release of encumbrance over 80,000,000 units (“**Released Units**”) (Details of the creation of encumbrance over these Units were intimated to you pursuant to disclosures dated June 24 2019, October 4 2019, June 24 2020, June 29 2020, and May 13 2021). Given that only 56,999,997 Released Units formed part of the Transferred Units, the balance Released Units will need to be re-pledged (we will submit an application for pre-clearance in this regard).

The Blackstone Sponsor Group held an aggregate of 357,597,188 Units, aggregating 37.72% of the total outstanding Units of the Embassy Office Parks REIT prior to the Trade, and all such Units were pledged. Post the Trade, the Blackstone Sponsor Group holds 300,597,191 Units, aggregating 31.71% of the total outstanding Units of the Embassy Office Parks REIT, of which 277,597,188 Units, aggregating to 29.29% continue to remain pledged as on date.

The total outstanding Units of the Embassy Office Parks REIT is 947,893,743 Units as on the date hereof and this has remained unchanged pursuant to the Trade.
