Purpose	Established to promote the protection, conservation, and sustainable use of biologically diverse ecosystems and habitats that may be impacted during the construction phase of the projects.	
	Embassy REIT recognises the value of protection of biodiversity and conservation of sustainable use of biologically diverse ecosystems and habitats. It also recognises that its assets can have a significant impact on biodiversity, hence focusing on the same. Embassy REIT supports its corporate responsibility towards biodiversity and sustainable development of its upcoming projects.	
	To this effect, Embassy REIT has developed the following policy supplement toward biodiversity conservation: <b>Risk Management:</b> Adopting a proactive approach and protecting biodiversity at even asset formation stage from concept, design, development and subsequently over the lifecycle of the asset. An Environmental Risk Mitigation Plan shall be established at a above stages and feasible measures shall be adopted, as applicable below:
