Aspects	<p>Embassy REIT recognises the importance of protection of biodiversity and conservation of biologically diverse ecosystems and habitats. We acknowledge that our assets can have a significant impact on biodiversity. We endeavour to align our initiatives to the UN Sustainable Development Goals, i.e. SDG 15: Life on Land as well as the 1993 United Nations Convention on Biological Diversity (CBD), as it may apply to the activities of Embassy REIT. We are also committed to comply with all applicable regulations with respect to biodiversity.</p> <p>At Embassy REIT, we endeavour to take proactive approach to preserve biodiversity and habitats throughout the lifecycle through the following measures:</p> <p>Risk Management:</p> <ul style="list-style-type: none"> ▪ [Relocating assets that may have a high impact on sensitive zones ▪ Investing in habitat restoration and creating a buffer zone around ecologically sensitive park ▪ Establishing site environmental risk mitigation plans covering short term and long-term measures for habitat conservation. ▪ Encouraging native vegetation through our landscaping activities.
