Ltd., BREP VII SBS Holding-NQ CO IV Ltd., BREP VII SG Indian Holding (NQ) CO I Pte. Ltd. (collectively, the "**Debenture Holders**") pursuant to, and as required under the terms of, the debenture trust deed dated November 13, 2019 executed between the Pledgor, the Debenture Trustee, the Debenture Holders (the "**Debenture Trust Deed**"). The pledge was created on November 14, 2019.
